NON-DISCLOSURE AGREEMENT

This agreement is made between _____ (hereinafter referred to as AUTHOR) and Stephanie Hider (hereinafter referred to as ILLUSTRATOR) for the purpose of protecting the confidentiality of the manuscript and the accompanying written materials that are going to be submitted to the ILLUSTRATOR by the AUTHOR in order to discuss potential illustration commission.

- **Confidential information.** For the purposes of this agreement, the term of confidential information means the manuscript of the book, as well as any accompanying written materials and information related to the future book that the AUTHOR wishes to publish.
- **Sharing and storing of files.** The AUTHOR intends to share the manuscript and other information related to the book using email or other file transfer system of her choice to send the documents to the ILLUSTRATOR. The ILLUSTRATOR expresses her intention to securely store the files on the personal computer and agrees to delete any copies of the files when asked to do so by the AUTHOR.
- **Use of information.** The confidential information is shared with the ILLUSTRATOR solely for the purpose of discussing the potential illustration work for the book and should not be used in any other way without prior permission from the AUTHOR.
- **Protection of information.** The ILLUSTRATOR will hold the manuscript and other information related to the book in strict confidence and will not share it with any person or entity without prior permission from the AUTHOR. The ILLUSTRATOR will not try to copy, modify or publish the manuscript or parts of it as their own work, or use the information acquired to intentionally cause harm to the AUTHOR or potential success of the book in any way.
- **Term.** This agreement of confidentiality shall be considered legally binding for 5 years from the day it is signed by both parties or until the official publication of the book, whichever happens first. If another agreement concerning the confidentiality of the manuscript and other information related to the book is written and signed by both parties, and contradicts the terms expressed in this agreement, the newest signed agreement or its version shall be considered to be in effect.

This agreement is entered into in good faith and upon signing it by both AUTHOR and ILLUSTRATOR indicates the acceptance of the agreement and the terms described herein.
